<b>Credit Requirements</b>	<p><b>Non-Credit Qualifying</b></p> <ul style="list-style-type: none"> <li>A Credit Report is required. The lowest decision score amongst borrowers is used. One of the following is acceptable: <ul style="list-style-type: none"> <li>Traditional Mortgage Only tri-merged credit report with minimum one credit score</li> <li>Soft-Pull Mortgage Only tri-merge credit report with minimum one credit score</li> </ul> </li> <li>0 x30 mortgage payment history required in the last 6 months</li> <li>Income/credit verification is not required when the following seven (7) conditions are met: <ul style="list-style-type: none"> <li>Current payment on the existing loan being refinanced is not 30 or more days past due</li> <li>Proposed IRRRL principal balance, (excluding fees and charges allowed by VA) is not more than the outstanding balance on the existing VA loan</li> <li>Total points and fees do not exceed 3% of the total proposed loan amount</li> <li>Interest rate on the proposed IRRRL is lower than the rate on the existing loan being refinanced unless the borrower is refinancing from an adjustable rate to a fixed rate</li> <li>Propose IRRRL payment is subject to a fully amortized payment schedule</li> <li>Terms of the proposed IRRRL do not require a balloon payment</li> <li>Proposed IRRRL and existing VA loan adhere to all other VA requirements</li> </ul> </li> <li>IRRRLs that do not meet all seven (7) requirements are still eligible for credit qualifying IRRRL</li> <li>If the P&amp;I payment increases 20% or more (standard VA guideline) loan is ineligible for non-credit qualifying IRRRL and must follow credit qualifying requirements. <b>Ineligible Programs</b>	<ul style="list-style-type: none"> <li>Energy Efficient Mortgages (EEM)</li> <li>Property with PACE Lien</li> <li>Property with resale restrictions (age restrictions are acceptable)</li> <li>Texas 50(a)6 transactions</li> </ul>

<b>Maximum Loan Amount Calculation/Loan Term</b>	<ul style="list-style-type: none"> <li><b>Maximum new loan amount</b> is the existing VA loan balance plus the following: <ul style="list-style-type: none"> <li>Allowable fees and charges (including up to two discount points)</li> <li>Any late fees</li> <li>VA Funding Fee</li> </ul> </li> <li>New loan may not include delinquent payments due on the existing VA mortgage</li> <li><b>Maximum loan term</b> is the original term of the VA loan being refinanced plus 10 years, but not to exceed 30 years and 32 days. (For example, if the old loan was made with a 15-year term, the term of the new loan cannot exceed 25 years)</li> </ul>

<b>Mortgage Credit Certificate (MCC)</b>	<ul style="list-style-type: none"> <li>Not permitted</li> </ul>
<b>Net Tangible Benefit (NTB)</b>	<p>All IRRRLs must evidence a net tangible benefit defined as follows:</p> <ul style="list-style-type: none"> <li>The proposed interest rate must be lower than the existing interest rate: <ul style="list-style-type: none"> <li>0.5% rate reduction required for Fixed to Fixed</li> <li>2.0% rate reduction required for Fixed to ARM <ul style="list-style-type: none"> <li>If discount points are utilized to reduce the interest rate, the LTV calculation is determined as follows: <ul style="list-style-type: none"> <li>≤ 1.000 discount point requires a ≤ 100% LTV</li> <li>&gt; 1.000 discount points requires a ≤ 90% LTV</li> </ul> </li> </ul> </li> <li>ARM to Fixed and ARM to ARM are exempt from rate reduction requirement</li> </ul> </li> <li>Fee recoupment must be ≤ 36 months after the date the loan closed <ul style="list-style-type: none"> <li>No more than 2.000 discount points can be charged</li> <li>Recoupment is calculated by dividing all fees, expenses, and closing costs—whether included in the loan or paid outside the loan or paid outside of closing (i.e. an appraisal fee)—by the reduction of the monthly PI payment <ul style="list-style-type: none"> <li>Borrower can only be charged for one appraisal/valuation product</li> </ul> </li> <li>The VA funding fee, escrow, and prepaid expenses, such as insurance, taxes, special assessments, and homeowners' association (HOA) fees, are excluded from the fee recoupment calculation</li> </ul> </li> </ul>
<b>Non-Occupant Co-Borrower</b>	<ul style="list-style-type: none"> <li>Ineligible</li> </ul>
<b>Non-Permanent Resident Aliens</b>	<p>These borrowers accepted under the following conditions:</p> <ul style="list-style-type: none"> <li>Acceptable visa evidence provided</li> <li>Borrower eligible to work in the U.S., as evidenced by EAD issued by the USCIS</li> <li>Borrower has valid Social Security Number (SSN)</li> <li>Borrower satisfies the same requirements, terms, and conditions as those for U.S. citizen</li> <li>DACA: Category C33 work status under deferred action, DACA borrowers allowed with proper documentation. <ul style="list-style-type: none"> <li>EAD must be current; if expiring within 1 year, evidence of history of renewals</li> <li>Income source must be stable with two-year work history</li> </ul> </li> <li>Diplomatic Immunity: Borrowers with Diplomatic Immunity are ineligible</li> </ul>
<b>Occupancy</b>	<ul style="list-style-type: none"> <li>Owner Occupied <ul style="list-style-type: none"> <li>Utility bill required on non-credit qualifying loans to evidence occupancy</li> </ul> </li> <li>Investment <ul style="list-style-type: none"> <li>Borrower must evidence subject property was previously occupied the property as a primary residence</li> </ul> </li> </ul>

<b>Power of Attorney (POA)</b>	<ul style="list-style-type: none"> <li>A POA may not be eSigned and must be specific to the transaction</li> <li>In addition, all the following is required: <ul style="list-style-type: none"> <li>Alive and Well Statement from commanding officer (if active duty)</li> <li>Underwriter must be able to validate the Veteran applied for the mortgage (lender certification is required)</li> <li>Specific POA is required; a Military POA may be used in cases where borrower is actively deployed</li> </ul> </li> </ul>
<b>Recently Listed Properties</b>	<ul style="list-style-type: none"> <li>Property must be off the market at least one day prior to mortgage application date.</li> </ul>
<b>Reserve Requirements</b>	<ul style="list-style-type: none"> <li>Reserves are not required</li> </ul>
<b>Seasoning Requirements</b>	<p>Seasoning requirements are applicable to all VA IRRRL refinances regardless of the type of loan paid.</p> <ul style="list-style-type: none"> <li>The new Note date must be: <ul style="list-style-type: none"> <li>210 days or more past the due date of the first monthly payment of the mortgage being refinanced, and</li> <li>After the date on which six (6) consecutive monthly payments have been made on the mortgage being refinanced</li> </ul> </li> <li>For modified loans, the Note date of the new loan must be: <ul style="list-style-type: none"> <li>210 days or more past the due date of the first monthly payment of the modified Note being refinanced, and</li> <li>After the date on which six (6) consecutive monthly payments have been made on the modified Note being refinanced</li> <li>At least six (6) full consecutive payments have been made in the month in which they were due on the original or modified mortgage</li> </ul> </li> <li>The following documents must be provided to evidence seasoning requirements are met: <ul style="list-style-type: none"> <li>Existing Note confirming the first payment due date for the mortgage being refinanced</li> <li>Credit report, credit report supplement or payment history verifying all payments were made in the required time period</li> </ul> </li> </ul> <p><b>Note:</b> Mortgage payments cannot be made in advance to meet the six consecutive payment requirements.</p>
<b>Social Security Number (SSN)</b>	<ul style="list-style-type: none"> <li>All borrowers must have a valid SSN</li> </ul>
<b>Subordinate Financing</b>	<ul style="list-style-type: none"> <li>Existing subordinate financing must be re-subordinated to the VA IRRRL</li> <li>New subordinate financing is not allowed</li> <li>No liens other than the existing VA loan may be paid off with proceeds of the IRRRL</li> </ul>
<b>Tax Transcripts</b>	<ul style="list-style-type: none"> <li>Required when tax returns are used to qualify borrower income</li> <li>Not required for non-credit qualifying IRRRL transactions</li> </ul>
<b>Temporary Buydowns</b>	<ul style="list-style-type: none"> <li>Ineligible</li> </ul>

<b>Underwriting Requirements</b>	<ul style="list-style-type: none"> <li>The following documents must be provided to evidence seasoning requirements and current interest rate: <ul style="list-style-type: none"> <li>Existing Note (confirming both the rate and the first payment due date for the mortgage being refinanced)</li> <li>Credit report, credit report supplement or payment history verifying all payments were made in the required time period</li> </ul> </li> </ul>
<b>VA Funding Fee</b>	<ul style="list-style-type: none"> <li>Funding Fee percentage (%) for first time and subsequent use is 0.50</li> </ul>
<b>Vesting</b>	<ul style="list-style-type: none"> <li>Joint loans are allowed, and borrowers may be removed in accordance with VA guidelines</li> <li>Only the Veteran and spouse, if applicable, can take title to the subject property. No other individuals are allowed to be added to title.</li> <li>Unless otherwise outlined in the VA Lenders Handbook Chapter Six, parties obligated on the original loan must be the same on the new loan (and the veteran must still own the property)</li> </ul>
<b>Verbal Verification of Employment (VVOE) Requirements</b>	<ul style="list-style-type: none"> <li>Verbal verification of employment is required for credit qualifying loans only</li> </ul>

<b>MANUFACTURED HOME GUIDELINES</b>	Criteria in this matrix apply to US Department of Veterans Affairs (VA) conforming <a href="#">guidelines</a> . Refer to the VA lender handbook for additional guidance. Information in this matrix is subject to change without notice.
<b>Standards (09/14/2015)</b>	<p>Appraiser must notify mortgagee and report any deficiency of MPR or MPS if a manufactured home does not comply with the following:</p> <ul style="list-style-type: none"> <li>Floor area must be <math>\geq 400</math> sq ft</li> <li>Constructed on or after June 15, 1976, in conformance with the federal MHCSS, as evidenced by an affixed HUD Certification Label in accordance with <a href="#">24 CFR §3280.11</a> (Manufactured Homes produced prior to June 15, 1976 are ineligible for insured financing.)</li> <li>Manufactured home and site exist together as a real estate entity in accordance with state law (but need not be treated as real estate for taxation purposes)</li> <li>Manufactured home was moved from the factory or dealer directly to the site</li> <li>Manufactured home was designed to be used as a dwelling with a permanent foundation built to comply with PFGMH</li> <li>Finished grade elevation beneath the manufactured home (or, if basement used, the grade beneath the basement floor) is at or above the 100-year return frequency flood elevation</li> <li>Structure is designed for occupancy as a principal residence by a single family</li> </ul>
<b>Flood Zone</b>	<ul style="list-style-type: none"> <li>Manufactured homes in a flood zone are ineligible</li> </ul>

TOPIC	CRITERIA
Foundation: Existing Construction	<ul style="list-style-type: none"> <li>Existing construction allowed, new construction is ineligible</li> <li><b>Definition:</b> Existing construction for manufactured housing refers to a manufactured home that has been permanently installed on a site for one year or more prior to the case number assignment date. <ul style="list-style-type: none"> <li>Preliminary title report must evidence subject is permanently affixed</li> </ul> </li> <li><b>Standard:</b> If the perimeter enclosure is non-load-bearing skirting comprised of lightweight material, the entire surface area of the skirting must be permanently attached to backing made of concrete, masonry, treated wood, or a product with similar strength and durability. <ul style="list-style-type: none"> <li><b>Skirting:</b> Skirting refers to a non-structural enclosure of a foundation crawl space that is typically, but not always, a lightweight material such as vinyl or metal attached to the side of the structure and extending to the ground (generally not installed below frost depth).</li> <li><b>Perimeter Enclosure (MPR/MPS Item):</b> The space beneath the manufactured home must be properly enclosed; the perimeter enclosure must be a continuous wall that is adequately secured to the perimeter of the unit and allows for proper ventilation of the crawl space.</li> </ul> </li> <li><b>Required Analysis and Reporting:</b> If the manufactured home foundation does not meet the requirements for Existing Construction, the appraiser must notify the mortgagee and report the deficiency in the MPR or MMPS.</li> </ul>
HUD Data Plate	<ul style="list-style-type: none"> <li><b>Standard HUD Data Plate Requirements:</b> Manufactured homes have a data plate affixed in a permanent manner, typically adjacent to the electric service panel, the utility room, or within a cabinet in the kitchen.</li> <li><b>Required Analysis and Reporting:</b> The appraiser must report the information on the data plate within the appraisal, including the manufacturer name, serial number, model, and date of manufacture, as well as wind, roof load, and thermal zone maps.</li> <li><b>Missing Data Plate (or Appraiser Cannot Locate):</b> If the data plate is missing or the appraiser is unable to locate it, the appraiser must report this in the appraisal and is not required to secure the data plate information from another source. <ul style="list-style-type: none"> <li><b>If the data plate is missing or appraiser cannot locate it, LSM requires an IBTS report.</b></li> </ul> </li> </ul>
IBTS Report/HUD Certification FHA	<ul style="list-style-type: none"> <li><b>HUD Certification Label Standard:</b> The manufactured home must have an affixed HUD Certification Label located at one end of each section of the house, approximately one foot up from the floor and one foot in from the roadside, or as near that location on a permanent part of the exterior of the house, as practicable. Etched on the HUD Certification Label is the certification label number, as referred to as the HUD label number. Label numbers are not required to be sequential on a multi-section house.</li> <li><b>Required Analysis and Reporting:</b> The appraiser must report the HUD label number for all sections, or report that the HUD Certification Label is missing or that the appraiser was unable to locate it. <ul style="list-style-type: none"> <li><b>If the Certification Label is missing or appraiser cannot locate it, LSM requires an IBTS report.</b></li> </ul> </li> </ul>

<b>Ineligible Features</b>	<ul style="list-style-type: none"> <li>• The following are not allowed in relation to a manufactured home: <ul style="list-style-type: none"> <li>○ Located in a co-op or condo project</li> <li>○ Located in a flood zone</li> <li>○ Manufactured home with a leasehold</li> <li>○ Manufactured home with an ADU or other dwelling structure</li> <li>○ New construction</li> <li>○ EEMs are not allowed for manufactured homes</li> <li>○ Graduated Payment Mortgage (GPM)</li> </ul> </li> </ul>
<b>Manufactured Home Additions</b>	<ul style="list-style-type: none"> <li>• Any addition to the original structure (i.e. patio, deck, carport, rooms, etc.) requires a structural engineer report. <ul style="list-style-type: none"> <li>○ If the appraiser observes additions or structural changes to the original manufactured home, the appraiser must condition the appraisal upon inspection by the state or local jurisdiction administrative agency that inspects manufactured housing for compliance (or a licensed structural engineer may report on the structural integrity of the manufactured dwelling and the addition if the state does not employ inspectors).</li> </ul> </li> </ul>
